## RESOLUTION ORDERING MAY 6, 2023 ELECTION

BE IT RESOLVED that the Board of Trustees of the Yoakum Independent School District hereby orders an election to be held on May 6, 2023 for the purpose of electing three (3) trustees to the Board of Trustees and chooses to hold the election on May 6, 2023, at the Yoakum City Hall Conference Room at 808 Hwy 77A South, Yoakum, Texas, between the hours of 7 a.m. and 7 p.m.

All applications for place on the ballot shall be filed with the Superintendent, as the Chief Elections Officer for the Yoakum Independent School District, at 315 E. Gonzales, Yoakum, Texas, before the filing deadline at 5:00 p.m. on February 17, 2023, and all declarations of write-in candidacy before the filing deadline at 5:00 p.m. on February 21, 2023.

Early voting by personal appearance will be conducted each weekday at Yoakum City Hall, 808 Hwy 77A South, Yoakum, Texas between the hours of 8 a.m. and 5 p.m. beginning on April 24, 2023, and ending on May 2, 2023. Applications for ballots by mail shall be mailed to: Theresa Bowe, Early Voting Clerk, P.O. Box 738, Yoakum, Texas, 77995. Applications for ballots by mail must be received no later than the close of business at 5 p.m. on April 25, 2023.

BE IT ALSO FURTHER RESOLVED that the Board of Trustees of the Yoakum Independent School District appoints the City Clerk and Deputy City Clerk as Early Voting Clerk and Deputy Early Voting Clerk for the election to be held on May 6, 2023. Early voting shall be conducted in the City Clerk's Office at City Hall, 808 Hwy 77A South, Yoakum, Texas, 77995.

BE IT ALSO FURTHER RESOLVED that the Board of Trustees of the Yoakum Independent School District appoints the City Election Judge, Irma Chomout, as Election Judge and the City Alternate Election Judge, Stephen Cuellar, as Alternate Election Judge for the election to be held on May 6, 2023. There shall be a minimum of two (2) and a maximum of four (4) clerks at the Election Day polling place, if needed, which does not include the Election Judge and the Alternate Election Judge. The presiding Election Judge and at least two (2) election clerks shall also serve as the Early Voting Ballot Board to count the ballots received in Early Voting by Personal Appearance and Early Voting by Mail.

DULY ENACTED by unanimous vote of the Board of Trustees at its regular meeting held on the 9<sup>th</sup> day of January, 2023, as same appears in its official minutes.
