1. Design of the construction shall be as authorized and approved by the Gonzales *County* Commissioners' agent or representatives' plans and specifications, as set forth in the Driveway Permit Regulations.
2. Maintenance of facilities constructed as requested shall be the responsibility of the grantee and the COUNTY OF GONZALES will reserve the right to require any changes, maintenance or as may be necessary to provide protection of life or property on or adjacent to the road. Changes in design when approved will be made only with approval of the County Commissioner or designated agent.
3. The applicant shall hold harmless the COUNTY OF GONZALES and its duly appointed agents, employees, and officials against any action for personal injury or property damages sustained by reason of the exercise of this application.
4. The applicant shall agree not erect any sip on or extending over any portion of the road right-of-way and vehicle service fixtures such as service pumps or vendor stands. Tanks or water hydrants will be located twelve (12) feet from the right-of-way to ensure that any vehicles serviced from these fixtures will be off the road.
