Application for ballots by mail will be available starting September 4, 2015 from the County Clerk's office located at 1709 Sarah Dewitt Dr, / PO Box 77 Gonzales, TX 78629; you may call 830-672-2801 to request an application be mailed to you.

THE NEW APPLICATION FOR A BALLOT BY MAIL CAN BE USED AS AN ANNUAL APPLICATION (ELECTIONS TAKING PLACE IN 2015), you must indicate on the application that is your wish. Applications must be received NO LATER THAN October 23, 2015; RECEIVED, NOT POSTMARKED! Beginning in March 2016 annual applications received by the County will be annual (if so indicated) and be forwarded to other election entities.

Mail ballots must be received by the County Clerk's office by ELECTION DAY, BY MAIL; in person delivery on ELECTION DAY, BY THE VOTER IN PERSON.

APPLICATION FOR A BALLOT BY MAIL MUST MEET ONE OF THE FOLLOWING REQUIREMENTS:

65 YEARS OF AGE OR OLDER; DISABILITY; CONFINMENT IN JAIL OR EXPECTED ABSENCE FROM THE COUNTY ON ELECTION DAY AND DURING THE PERIOD OF EARLY VOTING. BALLOTS FOR THIS REASON CAN ONLY BE MAILTO AN ADDRESS OUTSIDE OF THE COUNTY.

If you do not have any of the above listed forms of ID; you may apply for an ELECTION IDENTIFICATION CERTIFICATE from DPS driver's license office. (This card is only good for voting)
