To promote fair housing practices, COUNTY OF GONZALES encourages potential homeowners and renters to be aware of their rights under the National Fair Housing Law. Title VIII of the Civil Rights Act of 1968, as amended, prohibits discrimination against any person on the basis of race, color, religion, sex, disability, familial status or national origin in the sale or rental of units in the housing market. These procedures outline the steps for a citizen to follow if he/she wishes to file a complaint or grievance about GLO CDBG-MIT MOD activities.

A person who has a complaint or grievance about any services or activities with respect to the GLO CDBG-MIT MOD project may, during regular business hours, submit such complaint or grievance, in writing to Patrick C. Davis at the COUNTY OF GONZALES Courthouse located at 414 St. Joseph Street, Suite 200, Gonzales, TX 78629-4609, or by calling 830-672-2327. COUNTY OF GONZALES will make every effort to respond fully to such complaints or grievances within fifteen (15) working days where practicable after receipt of the original complaint or grievance.
